### Call For Entry

Wayne Art Center is pleased to announce the Call for Work for our annual *Expressions of Radnor 2026*. Each year Wayne Art Center is proud to showcase artwork created by Radnor Township residents across a wide range of artistic mediums and perspectives. Eligible artists are invited to exhibit up to two works in *Expressions of Radnor 2026*.

All entries will be processed with **EntryThingy** in advance of artwork delivery. Visit us online at [wayneart.org](http://wayneart.org) to register your work for this show. This exhibition is open to township residents only and will be juried for awards in-gallery.

### Eligibility

Artists 18 years and older who are legal residents of Radnor Township are eligible to exhibit up to two original pieces of artwork in any 2D or 3D medium: painting, drawing, sculpture, ceramics, jewelry, fiber, photography, wood, metal, glass or mixed-media. Work must have been created in the last two years and not previously shown at WAC.

### Entry Guidelines

This is an OPEN CALL for Radnor Township artists.

The Exhibition Juror will jury for awards only.

All artwork must be registered online before delivery. An **Entry Fee of \$25 per piece** for up to two works per artist will be processed online with your submission.

2D work MUST be framed and ready to hang. D-rings are preferred for hanging. All 3D work should be sturdy, stable and secured to a base. Work that is not properly presented will not be accepted.

### Sales & Insurance

All work must be available for sale. WAC retains 40% commission on all sold works. Submitted prices should include this commission fee and cannot be changed once declared. Work will be insured for 60% of the retail value declared on EntryThingy. Artists receive payment for sold work within 45 days of the close of the exhibit. W9s required.

### Delivery & Pickup of Artwork

Work must be at WAC by 5PM on 2/9/26 and remain on exhibit through 3/14. Work that is not claimed by 3/27 will no longer be insured and becomes property of WAC. Volunteers to assist with delivery and pick-up are requested.

### Exhibition Juror

Painter and instructor Ernie Norcia serves as juror of awards for *Expressions of Radnor 2026*.


